3. Signatures of ALL persons must be on the application form and liability release form. The signature of the parent/guardian of anyone under the age of 18 must appear next to the signatures of those persons under the age of 18, indicating that relationship.
4. Submission of this form grants the permission of every person in each act, to have his/her/their likeness(es) shown or heard on radio, TV, newspaper or other media associated with reports of this event and/or promotion for future such events.
5. Should the event be canceled, contestants will be notified of where, when and if the competition will be re-scheduled.
6. Competition may include the following types of acts: Vocal Soloist, Vocal Group, Novelty, Instrumentals, Martial Arts, Drama/Theatre, Dance, etc. Other categories may be considered.
7. Any and all pre-recorded music must be provided to contest coordinators on CD ONLY. No cassettes or other media will be accepted. It is preferred that the CD contains ONLY the selected piece of music to avoid any complications on stage. Each CD disc (not the case) must be clearly labeled with the entrant's name and cut number (if any). Bringing a backup CD is always a good idea. We do not guarantee the return of your CD after your performance.
8. Contestants must remember that this is a FAMILY-ORIENTED event! Any act will be pulled from the stage if organizers believe the act to be in any way inappropriate for this event and disqualified from competition.
  - i) All decisions of the judges are final.
9. All acts will be notified ahead of time when they will be competing. Some alternates may also be notified in case an act or acts fail(s) to show up.

10. All contestants and alternates must be at the staging area 30 minutes prior to performance.
  11. The act will be provided with the date and time in advance of the contest. If an act is not ready to go on stage when called upon, that act may be removed from the competition.
  12. Contestants must furnish all costumes and special properties required for their act. There will not be a dressing facility available.
  13. All contestants will use only lighting systems and sound systems as provided by Nevada Wild Fest.
  14. **Acts are allowed a maximum of 5 minutes.** Set-up time will be scheduled for a maximum of 1 minute unless otherwise approved by Nevada Wild Fest.
